NOTES TO FINANCIAL STATEMENTS



1. General Information

The Philippine Army Internally Generated Fund (Off-Budgetary Fund-Retained Income) was established under COA-DBM-DOF Joint Circular No. 2013-1 dated 06 August 2013 with subject Enhancement of Unified Account Code Structure which discontinued the maintenance of National Government Book but instead, existing records shall be transferred to appropriate books per fund which was also re-iterated under COA Circular 2014-003 dated 15 April 2014. This circular took effect and was implemented dated 01 January 2014.

The Philippine Army Hospital was established to deliver quality healthcare services to military personnel of active service, dependents, survivors, and authorized civilian personnel of Philippine Army.

2. Statement of Compliance and Basis of Preparation of Financial Statements

2.1 The financial statements have been prepared in accordance with and complied with the Philippine Public Sector Accounting Standards (PPSAS) issued by the Commission on Audit per COA Resolution No. 2014-003 dated January 24, 2014.

2.2 Treatment of Fund

PA Internally Generated Fund (IGF) is treated as retained income by which collections from its services is directly deposited to Authorized Government Depository Bank in accordance with Personnel Directive Number 01 dated 02 January 2008 issued by GHQ-AFP. Out of this collection or income, 25% will be used to purchase and upgrade health services and facilities per Joint Circular of DND-DOF-DBM No. 1-06 dated 12 Dec 2006.

3. Summary of Significant Accounting Policies

3.1 Basis of accounting

The financial statements are prepared on an accrual basis in accordance with the Philippine Public Sector Accounting Standards (PPSAS). The transactions and events are recognized in the accounting records and recognized in the financial statements of the periods to which they relate.

3.2 Changes in Accounting Policies and Estimates

The Philippine Army recognizes the effects of changes in accounting policy retrospectively and recognizes the effects of changes in accounting estimates

prospectively by including in surplus or deficit. The Philippine Army corrects material prior period errors retrospectively in the first set of financial statements authorized for issue after their discovery by:

- Restating the amount for prior period(s) presented in which the error occurred; or
- If the error occurred before the earliest period presented, restating the opening balances of the assets, liabilities and net assets/equity for the earliest prior period presented.

3.3 Recognition of Payables

Payables are recognized and recorded in the books of accounts only upon acceptance of goods and/or performance of services to the Fund.

3.4 Recognition of Expenses

Expenses are recognized when incurred and reported in the financial statements in the period in which they relate.

3.5 Correction of Fundamental Errors

Fundamental errors of prior years are corrected by adjusting directly the Accumulated Surplus/ (Deficit) account. Errors affecting current year's operations are charged to the current year's accounts

- 6.1 The Due from Government-Owned and/or Controlled Corporations (GOCCs) account represents unliquidated balance of fund transfer to Philippine International Trading Corporation (PITC) for procurement of various equipments for use of AGH, ASCOM, PA.
- 6.2 The Due from Officers and Employees account represents the over-remittance to BIR due to erroneous computation of withholding tax from payment to Deokma Eight Trading, Inc. under Disbursement Voucher No 1712-19576 dated 29 December 2017.

7. Property, Plant and Equipment

The Property, Plant and Equipment (PPE) accounts are stated at cost less accumulated depreciation. The computation of the depreciation expense starts when the asset is available for use such as when it is in the location and condition necessary for it to be capable of operating in the manner intended by the management. Depreciation shall be for one month if the PPE is available for use on or before the 15th of the month. However, if the PPE is available for use after the 15th of the month, depreciation shall be for the succeeding month. Depreciation is computed based on the straight line method, net of residual value equivalent to 5% of the acquisition cost as per COA Circular 2015-002 dated 09 March 2015 over the estimated useful lives of the related assets.
