The Armed Forces of the Philippines, through the PASBAC now calls for the request for Expression of Interest (EOI) and submission of eligibility documents for **Procurement of Consulting Services for the Requirements in Connection with the Master Development Plan (MDP) for Headquarters 103rd Infantry Brigade in Kampo Ranao, Marawi City and Consulting Services for the Requirements in Connection with the Master Development Plan (MDP) for Old City Hall Area in Marawi City** Interested consultants must submit their eligibility documents not later than **November 27, 2019, 9:30 A.M at Ugnayan Hall, HHSG Philippine Army Fort Andres Bonifacio, Metro Manila**. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

In accordance with the provisions of Republic Act 9184, otherwise known as the "Government Procurement Reform Act", and its 2016 Revised Implementing Rules and Regulations (RRIR), the PASBAC shall come up with a shortlist of local Consultancy Firms (CF) that have submitted Eligibility documents/Expression of Interest. Only those CFs that will be declared eligible and included in the short list will be entitled to submit bids.

The PASBAC will evaluate the Technical Proposals using the Quality Based Evaluation (QBE) Procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instruction to Bidders.

The Contract shall be completed within **Three Hundred (300) Calendar days** from receipt of Notice to Proceed.

The PASBAC reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.


