The Bidding Documents shall be available at the Office of the Philippine Army Bids and Awards Committee-2 Secretariat, Fort Andres Bonifacio, Metro Manila starting **15 October 2020** upon payment of **non-refundable fee at the Collecting Officer Finance Center, Philippine Army, Fort Bonifacio, Metro Manila.**

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bid Conference/s, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Revised Implementing Rules and Regulations of RA 9184, as amended.

The Pre-Bid Conference and Receipt, Opening of Bids and Evaluation (ROBE) shall be held thru **Virtual Tele Conference (VTC) via ZOOM.**

RA 9184, Section 22.3 that the Pre-Bid Conference shall discuss, clarify and explain, among other things, the eligibility requirements and the technical and financial components of the contract to be bid including questions and clarifications raised by the prospective bidders before and during the Pre-Bid Conference.

During Pre-Bid Conference all prospective bidders are allowed to participate and ask questions. However, request for clarifications on any part of the bidding documents or for an interpretation must be in writing and submitted to the BAC of the Procuring Entity concerned at least ten (10) calendar days before the deadline set for the submission and receipt of bids. The BAC shall respond to the said request by issuing a Supplemental/Bid Bulletin, duly signed by the BAC Chairperson, to be made available to all those who have properly secured the bidding documents, at least seven (7) calendar days before the deadline for the submission and receipt of bids.

During the **ROBE**, the bidders or their “duly authorized representative shall submit their bids using the forms specified in the Bidding Documents in two (2) separate sealed bid envelopes, and which shall be submitted simultaneously. The first shall contain the technical component of the bid, including the eligibility requirements under section 23.1 of

Revised IRR, and the second shall contain the financial component of the bid” under **Section 25.1**.
