ORD PABAC 045-19 Procurement of 11,551 ea Assault Rifle, 5.56mm M4/AR15

This Supplemental/Bid Bulletin is issued to amend certain provisions in the bidding documents for the Procurement of 11,551 ea Assault Rifle, 5.56mm M4/AR15 under ORD PABAC 045-19 for the Philippine Army.

In reference to the queries raised by the Proponents for the said project, the PA Technical Working Group for Ordnance-Firearms decided to recommend for the amendment of some provisions in the bid documents to rectify errors herein as stated below:
