**Procurement of Passenger Van for the Philippine Army

1. The Philippine Army, through **ASA Nr 0202 dated 03 April 2020** (continuing fund) with an amount of **Five Million Five Hundred Thousand Pesos (PhP5,500,000.00)** included in the Capital Outlay CY 2019 intends to apply the following sums of Pesos: **Five Million Two Hundred Thousand Pesos (Ph5,200,000.00) (DDP - Delivered Duty Paid)** being the Approved Budget for the Contract (ABCs) to payments under the contract for the Procurement of two (2) units Passenger Van for the Philippine Army under Bid Ref. No. **ORD PABAC2 010-20**. Bids received more than the ABC shall be automatically rejected a bid opening.

2. Philippine Army Bids and Awards Committee 2 (PABAC2) now invite Bids from eligible **Authorized Distributor; Local or Foreign Manufacturers** for the above Procurement Project (hereafter referred to as GOODS). However, foreign manufacturers must be represented by a duly registered Philippine-based company. Required delivery period and delivery place shall be as follows:

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Awards of Contract shall be governed by R.A. 9184 and its 2016 Revised IRR.

Bidding is open to all interested bidders, whether **local or foreign**, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Prospective Bidders may obtain further information from the PABAC Secretariat and inspect the Bidding Documents at the address given below during 8:00am – 4:00pm on weekdays only.

The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PABAC website. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00 am - 4:00 pm) on weekdays only.

The complete set of Bidding Documents may be acquired/purchased by interested Bidders starting **03 December 2020** during office hours (8:00 am - 4:00 pm) from the given address and websites below upon payment of **non-refundable fee at the Collecting Officer, Finance Center, Philippine Army, Fort Andres Bonifacio, Metro Manila.**

6. The Philippine Army will hold a Pre-Bid Conference on **10 December 2020, 1:30 P.M.** thru Virtual Tele Conference (VTC) via ZOOM which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **22 December 2020, 1:30 P.M.** Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on **22 December 2020, 1:30 P.M.** thru Virtual Tele Conference (VTC) via ZOOM. Bids will be opened in the presence of the bidder's representatives who choose to attend the activity.

10. For Pre-Bid Conference and Bid Opening;

However, **only bidders who purchased the bidding documents** may join the Opening of Bids and send their request for Zoom Link and Password to **pabacsec2@gmail.com** together with proof of identity (**Valid ID: Passport, Govt issued ID**) of the attendee a day before the schedule conference.

Bidding Document may also be downloaded free of charge from the website of the PhilGEPS and the Army website. However, only those who have paid the cost of Bidding Documents at least one (1) day before the submission of their bids will be allowed to bid.

The *Philippine Army* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


