The **Philippine Army**, through the **Certificate of Funding Chargeability from MFO, 51<sup>st</sup> EBde, PA dated 19 January 2021 signed by MAJ ANABELLE R PARAAN (CE) PA, Chief, MFO concurred by BGEN LYNDON J SOLLESTA PA, Commander, 51EBde, PA charged against Check Number: 0000640119 dated 22 May 2019** intends to apply the sum of **Fourteen Million Four Hundred Fifty-Eight Thousand Three Hundred Sixty-Four Pesos (PhP14,458,364.00)** being the ABC to payments under the contract for **Supply and Delivery of Materials for the Renovation and Improvement of Capas National Shrine at Brgy Aranguren, Capas, Tarlac** with Bid Reference No. **ENG'G PABAC3 008-21**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Office of the Philippine Army Bids and Awards Committee 3 (PABAC3)** and inspect the Bidding Documents at the address given below during **Office Hours from 8:00am to 5:00pm**.

5. A complete set of Bidding Documents may be acquired by interested Bidders on March 8, 2021 from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (PhP25,000.00)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees and it will be presented in person during the ROBE.

6. The **Philippine Army**, will hold a Pre-Bid Conference on March 16, 2021, 9:30 A.M. at **Army Support Command (ASCOM) Multi-Purpose Hall** and/or through video conferencing or webcasting *via ZOOM*, which shall be open to prospective bidders.

7. Bids must be duly received by the PABAC3 Secretariat through manual submission at the office address indicated below, on or before March 30, 2021, 9:30 A.M. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

9. Bid opening shall be on March 30, 2021 at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
