The Philippine Army, through ASA 2200-2021-0127 dated 17 February 2021 with an amount of THIRTY-FIVE MILLION TWO HUNDRED THOUSAND PESOS ONLY (\$\P\$35,200,000.00) included in the program of the Philippine Army based on FY 2021 per Budget Level National Expenditure Program (NEP) intends to apply the amount of Thirty Million Four Hundred Thousand Pesos Only (\$\P\$30,400,000.00) (DDP - Delivered Duty Paid) being the Approved Budget for the Contract (ABCs)to payments under the contract for the Procurement of General Purpose Vehicle for the Philippine Army under Bid Ref. No. ORD PABAC2 014-07-21. Bids received more than the ABC shall be automatically rejected at bid opening.

Bidders should have completed within **five (5) years** from the date of Submission and Receipt of Bids a Contract similar to the project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

- 4. Prospective Bidders may obtain further information from PABAC2 Secretariat and inspect the Bidding Documents at the address given below during office hours from 8:00 am to 4:00 pm.

- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on the date as specified below and at the given address below through in person (face to face) and/or through video conferencing or



webcasting. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
