### **INVITATION TO BID**

#### **Procurement of Various MED Items**

1. The Philippine Army, through the General Appropriations Act (GAA) intends to apply the sum of Sixteen Million Pesos Only (PhP 16,000,000.00) corresponding to the total cost of each item to bid for the Procurement of Al-Mg (OH) 60 ml suspension and 162 other Drugs and Medicines under MED PABAC 001-2021 and Procurement of Absorbable Hemostat (2.5cm x 5cm), 2's and 358 other Medical Supplies under MED PABAC 002-2021 being the ABC to payments under the contract for each Line item. Bids received in excess of the ABC shall be automatically rejected at bid opening:

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
