Certification dated 30 September 2020 amounting to **EIGHT BILLION ONE HUNDRED THREE MILLION EIGHT HUNDRED THIRTY-SIX THOUSAND EIGHT HUNDRED NINETY PESOS AND EIGHTEEN CENTAVOS (PhP8,103,836,890.18)** duly signed by COL PEDRO C BALISI JR MNSA (CAV) PA, Chief OAFM intends to apply the following sum being the Approved Budget for the Contract (ABCs) to payments under the contract for each item. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
