The Philippine Army, through OAFM Certification dated 30 September 2020 with an amount of EIGHT BILLION ONE HUNDRED THREE MILLION EIGHT HUNDRED THIRTY-SIX THOUSAND EIGHT HUNDRED NINETY PESOS AND 18/100 (Ph8,103,836,890.18) included in the program of the Philippine Army based on FY 2021 per Budget Level National Expenditure Program (NEP) intends to apply the following sums of Pesos: One Hundred Sixty Seven Million Four Hundred Twenty-One Thousand Four Hundred pesos (PHP167,421,400.00) being the Approved Budget for the Contract (ABCs) to payments under the contract for the Procurement of various Grenades for the Philippine Army under Bid Ref. 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
