The Philippine Army, through the Advice of Sub-Allotment (ASA) Number 2200-2020-0093 dated 21 February 2020 duly signed by **COL PEDRO C BALISI JR MNSA (CAV) PA**, Chief OAFM, PA intends to apply the following sum being the Approved Budget for the Contract (ABC) to payment under the contract for the item. Bidders should have completed within **five (5) years** from the date of Submission and Receipt of Bids a Contract similar to the project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
