The Philippine Army, through the Philippine Army Appropriation CY 2019 with Advise of Sub-Allotment (ASA) Nr. 2200-2019-0428 dated 29 October 2019 and Advise of Sub-Allotment (ASA) Nr. 2200-2019-0430 dated 30 October 2019, valid until 31 December 2020 intends to apply the sum of THIRTY-NINE MILLION NINE HUNDRED THIRTY-FIVE THOUSAND PESOS (**Php39,935,000.00**) being the ABC to payments under the contract for the Procurement of 815 sets Integrated Armor Vest System under **QM PABAC 031-20 (Lot 1)** and Philippine Army Appropriation CY 2020 with Certificate of Availability of Fund dated 21 October 2019 and 17 November 2019, valid until 31 December 2020 intends to apply the sum of SEVENTY-SEVEN MILLION SIX HUNDRED SIXTY-FIVE THOUSAND PESOS (**Php77,665,000.00**) being the ABC to payments under the contract for the Procurement of 1,585 sets Integrated Armor Vest System under **QM PABAC 031-20 (Lot 2)**. Bids received in excess of the ABC shall be automatically rejected a bid opening.

Bidders should have completed within **five (5) years** from the date of Submission and Receipt of Bids a Contract similar to the project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.


