**INVITATION TO BID FOR**

**Supply and Delivery of Materials for the Additional Works on Repair and Renovation of Veterans Center at Camp Emilio Aguinaldo, Quezon City**

**Bid Reference No. ENG'G PABAC3 009-21**

1. The **Philippine Army**, through the **Certificate of Funding Chargeability** dated **02 March 2021** with **Check Number 0000640045** dated **24 January 2019** intends to apply the sum of **One Million Nine Hundred Thirty-Nine Thousand Nine Hundred Forty-Three and 9/100 Pesos (PhP1,939,943.09)** being the ABC to payments under the contract for **Supply and Delivery of Materials for the Additional Works for the Repair and Renovation of Veterans Center at Camp Emilio Aguinaldo, Quezon City** with Bid Reference No. **ENG'G PABAC3 009-21**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Philippine Army**, now invites bids for the above Procurement Project.

Required delivery period and delivery place shall be as follows:

Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the **Office of the PABAC3** and inspect the Bidding Documents at the address given below during **Office Hours from 8:00am to 5:00pm.**

5. A complete set of Bidding Documents may be acquired by interested Bidders on *06 April 2021* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (PhP5,000.00).* The Procuring Entity shall allow the bidder to present its proof of payment for the fees and it will be presented in person during the ROBE.

6. The **Philippine Army**, will hold a Pre-Bid Conference on **13 April 2021, 9:30 A.M.** at **ASCOM Multi-Purpose Hall** and/or through video conferencing or webcasting *via ZOOM*, which shall be open to prospective bidders.

7. Bids must be duly received by the PBAC3 Secretariat through manual submission at the office address indicated below, on or before **27 April 2021, 9:30 A. M.** Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

9. Bid opening shall be on **27 April 2021, 9:30 A.M.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
