The Philippine Army, through ASA 2200-2021-0113 dated 16 February 2021 with an amount of THIRTY MILLION PESOS ONLY (₱30,000,000.00) and ASA 2200-2021-0114 dated 16 February 2021 with an amount of TWENTY MILLION PESOS ONLY (₱20,000,000.00), intends to apply the following sum being the Approved Budget for the Contract (ABCs) to payments under the contract for the Procurement of Spares (Lot 1) for the Philippine Army under Bid Ref. - 8. Bids must be duly received by the PABAC2 Secretariat through manual submission at the office address indicated below on or before the date of submission of bids as specified below. Late bids shall not be accepted.
- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on the date as specified below and at the given address below through in person (face to face) and/or through video conferencing or webcasting. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
