The Philippine Army, through ASA 2200-2021-0152 dated 03 March 2021 with an amount of THIRTY MILLION TWO HUNDRED TWELVE THOUSAND SIX HUNDRED FORTY NINE PESOS ONLY (\$\rightarrow\$30,212,649.00) and ASA 2200-2021-0153 dated 03 March 2021 with an amount of TWENTY EIGHT MILLION FIVE HUNDRED FOURTEEN THOUSAND THREE HUNDRED NINETY NINE PESOS AND 55/100 ONLY (\$\rightarrow\$28,514,399.55), intends to apply the following sums being the Approved Budget for the Contract (ABCs) to payments under the contract for the Procurement of Spares for the Philippine Army under Bid Ref. No. ORD PABAC2 016-05-21. Bids received more than the ABC shall be automatically rejected at bid opening.

Bidders should have completed within **five (5) years** from the date of Submission and Receipt of Bids a Contract similar to the project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

- 4. Prospective Bidders may obtain further information from PABAC2 Secretariat and inspect the Bidding Documents at the address given below during office hours from 8:00 am to 4:00 pm.
- 5. The complete set of Bidding Documents may be acquired/purchased by interested Bidders starting <u>11 May 2021</u> during office hours (8:00 am 4:00 pm) from the given address and websites below upon payment of non-refundable fee at the Collecting Officer, Finance Center, Philippine Army, Fort Andres Bonifacio, Metro Manila.

- 8. Bids must be duly received by the PABAC2 Secretariat through manual submission at the office address indicated below on or before the date of submission of bids as specified below. Late bids shall not be accepted.
- 9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on the date as specified below and at the given address below through in person (face to face) and/or through video conferencing or



webcasting. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
