The Philippine Army, through the Certificate of Funding Chargeability from MFO, 51st EBde, PA signed by MAJ ANABELLE R PARAAN (CE) PA, Chief, MFO concurred by BGEN LYNDON J SOLLESTA PA, Commander, 51EBde, PA charged against Check Nr.: 0000640090 dated 14 February 2019 intends to apply the sum of One Million Six Hundred Sixty-Two Thousand Four Hundred Nineteen Pesos and 55/100 (1,662,419.55) being the ABC to payments under the contract for Supply and Delivery of Air Condition Units for the Mechanical Works in Connection with Repair and Renovation of Veterans Center with Bid Reference No. ENG'G PABAC3 010-21. Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project.

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
