Supply and Delivery of Doors and Windows for the Specialty Works in Connection with Repair and Renovation of Veterans Center (1-Lot)

- 1. The Philippine Army, through the Certificate of Funding Chargeability from MFO, 51st EBde, PA signed by MAJ ANABELLE R PARAAN (CE) PA, Chief, MFO concurred by BGEN LYNDON J SOLLESTA PA, Commander, 51EBde, PA charged against Check Nr.: 0000640090 dated 14 February 2019 intends to apply the sum of One Million Two Hundred Fifty-Two Thousand Four Hundred Fifty-Four Pesos and 02/100 (PhP1,252,454.02) being the ABC to payments under the contract for Supply and Delivery of Doors and Windows for the Specialty Works in Connection with Repair and Renovation of Veterans Center (1-Lot) with Bid Reference No. ENG'G PABAC3 011-21. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Philippine Army**, now invites bids for the above Procurement Project.

Required delivery period and delivery place shall be as follows:

Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).



3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from Office of the Philippine Army Bids and Awards Committee 3 (PABAC3) and inspect the Bidding Documents at the address given below during Office Hours from 8:00am to 5:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on April 12, 2021 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PhP5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees and it will be presented in person during the ROBE.
- 6. The **Philippine Army**, will hold a Pre-Bid Conference on **April 16, 2021, 9:30 A.M.** at Army Support Command (ASCOM) Multi-Purpose Hall and/or through video conferencing or webcasting *via* ZOOM, which shall be open to prospective bidders.
- 7. Bids must be duly received by the PABAC3 Secretariat through manual submission at the office address indicated below, on or before **April 29, 2021, 9:30 A.M.** Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on <u>April 29, 2021, 9:30 A.M.</u>at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
