## **Invitation to Bid**

Supply and Delivery of Materials for the Construction of Ammo Dump-Igloo Type at Camp Siongco, Awang Dos, Maguindanao

### Bid Reference No. ENG'G PABAC3 049-21

- 1. The Philippine Army, through the Certificate of Funding Chargeability signed by CAPT MARCO D ABANTE (CE) PA, Chief, MFO, 54EBde, PA concured by COL RANDY F FAJILAGUTAN CE (MNSA) PA. Commander 54EBde, PA under Advise of Sub-allotment (ASA) with Advise No.: 5400-2022-0038 dated 02 February 2022 intends to apply the sum of Five Million Four Hundred Twenty-Five Thousand Four Hundred Sixty-Four (PhP5,425,464.00) being the ABC to payments under the contract for Supply and Delivery of Materials for the Construction of Ammo Dump-Igloo Type at Camp Siongco, Awang Dos Maguindanao with Bid Reference No. ENG'G PABAC3 049-21. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Philippine Army**, now invites bids for the above Procurement Project.

Required delivery period and delivery place shall be as follows:

Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).



3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from Office of the PA Bids and Awards Committee 3 (PABAC3) Fort Bonifacio, Metro Manila and inspect the Bidding Documents at the address given below during Office Hours from 8:00am to 5:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **01 June 2022** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (PhP10,000.00).** The Procuring Entity shall allow the bidder to present its proof of payment for the fees and it will be presented in person during the ROBE.
- 6. The Philippine Army will hold a Pre-Bid Conference on 08 June 2022, 9:30 A.M. at Office of the PA Bids and Awards Committee 3 (PABAC3) Fort Bonifacio, Metro Manila and/or through videoconferencing/webcasting via ZOOM, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the Office of the PA Bids and Awards Committee 3 (PABAC3) Fort Bonifacio, Metro Manila, on or before 21 June 2022, 9:30 A.M. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on 21 June 2022, 9:30 A.M. at the Office of the PA Bids and Awards Committee 3 (PABAC3) Fort Bonifacio, Metro Manila. Bids will be opened in the presence of the bidders' representatives physically or virtually (via ZOOM).
