The Philippine Army, through the Certificate of Funding Chargeability signed by MAJ ANABELLE R PARAAN (CE) PA concurred by Colonel JT J BAJET MNSA (CE) PA under Advice of Sub-Allotment (ASA) dated 23 April 2021 with ASA Nr 5100-2021-0215 intends to apply the sum of Four Million One Hundred Twenty-Four Thousand Two Hundred Twenty Pesos (PhP4,124,220.00) being the ABC to payments under the contract for Supply and Delivery of Materials for the Ground Development of Unmanned Aerial System (UAS) Level 3 at Fort Magsaysay, Nueva Ecija with Bid Reference No. ENG'G PABAC3 007-22 (1st Rebid). Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project.

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Office of the PA Bids and Awards Committee 3 (PABAC3)** and inspect the Bidding Documents at the address given below during **Office Hours from 8:00am to 5:00pm.**

5. A complete set of Bidding Documents may be acquired by interested Bidders on **14** January 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (PhP5,000.00) only. 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
