The Philippine Army, through the Certificate of Funding Chargeability dated 19 May 2021 signed by MAJ ANABELLE R PARAAN (CE) PA, Chief, MFO, 51EBde, PA concurred by BGEN LYNDON J SOLLESTA PA, Commander 51EBde, PA under Advice of Sub-Allotment (ASA) with ASA No: 5100-2021-0038 dated 08 February 2021 intends to apply the sum of Three Million Five Hundred Thirty-Four Thousand Four Hundred Pesos (PhP3,534,400.00) being the ABC to payments under the contract for Supply and Delivery of Forty-Seven (47) Units 2.0HP, Split Type, Wall Mounted, Inverter Air Condition Units and Forty-Seven (47) Units Telephone Corded Handset at Fort Bonifacio, Metro Manila with Bid Reference No. ENG'G PABAC3 029-21. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Philippine Army**, now invites bids for the above Procurement Project.

Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project.

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Office of the PA Bids and Awards Committee 3 (PABAC3)** and inspect the Bidding Documents at the address given below during **Office Hours from 8:00am to 5:00pm.**

5. 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
