Glossary of Acronyms, Terms, and Abbreviations

ABC – Approved Budget for the Contract.

BAC – Bids and Awards Committee.

Bid – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR – Bureau of Internal Revenue.

BSP – Bangko Sentral ng Pilipinas.

Consulting Services – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

CDA - Cooperative Development Authority.

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

CIF – Cost Insurance and Freight.

CIP – Carriage and Insurance Paid.

CPI – Consumer Price Index.

DDP – Refers to the quoted price of the Goods, which means “delivered duty paid.”

DTI – Department of Trade and Industry.

EXW – Ex works.

FCA – “Free Carrier” shipping point.

FOB – “Free on Board” shipping point.

Foreign-funded Procurement or Foreign-Assisted Project–Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

Framework Agreement – Refers to a written agreement between a procuring entity and a supplier or service provider that identifies the terms and conditions, under which specific purchases, otherwise known as “Call-Offs,” are made for the duration of the agreement. It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

GFI – Government Financial Institution.

GOCC –Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term “related” or “analogous services” shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

GOP – Government of the Philippines.

GPPB –Government Procurement Policy Board.

INCOTERMS – International Commercial Terms.

Infrastructure Projects – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national

buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

LGUs – Local Government Units.

NFCC – Net Financial Contracting Capacity.

NGA – National Government Agency.

PhilGEPS - Philippine Government Electronic Procurement System.

Procurement Project – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

PSA – Philippine Statistics Authority.

SEC – Securities and Exchange Commission.

SLCC – Single Largest Completed Contract.

Supplier – refers to a citizen, or any corporate body or commercial company duly organized and registered under the laws where it is established, habitually established in business and engaged in the manufacture or sale of the merchandise or performance of the general services covered by his bid. (Item 3.8 of GPPB Resolution No. 13-2019, dated 23 May 2019). Supplier as used in these Bidding Documents may likewise refer to a distributor, manufacturer, contractor, or consultant.

INVITATION TO BID FOR THE PROCUREMENT OF **13,928 EACH** **PONCHO TENT, PHILARPAT**

1. The Philippine Army, through the Philippine Army Appropriation CY 2024 with OG10 Certification dated 15 August 2023 valid until 31 December 2024, intends to apply the sum of Fifteen Million Three Hundred Twenty Thousand Eight Hundred Pesos (Php15,320,800.00) being the ABC to payments under the contract for the Procurement of 13,928 each Poncho Tent, PHILARPAT under QM PABAC1 025-24. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Army now invites bids for the above Procurement Project. Delivery of the Goods is required **One Hundred Twenty (120) calendar days** from the receipt of Notice to Proceed (NTP) by the supplier, which date shall not be later than seven (7) days from the issuance of NTP. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184

4. Prospective Bidders may obtain further information from the Philippine Army and inspect the Bidding Documents at the address given below office hours (8:00AM to 4:00PM) on weekdays only (except holidays).
5. A complete set of Bidding Documents may be acquired by interested Bidders on _____ from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of **Twenty-Five Thousand Pesos (PhP25,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
6. The Philippine Army through PABAC1 will hold a Pre-Bid Conference on the time and date as specified below at the Office of the PABAC1, Fort Andres Bonifacio, Taguig, City and/or through video conferencing or webcasting via Zoom, which shall be open to prospective bidders. Only One (1) representative per bidder will be accommodated

on the venue. Other representatives will attend through VTC. Zoom link will be provided one hour before the start of the PRE-BID Conference

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before the date of submission. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on the date as specified below and at the given address below and/or through video conferencing or webcasting. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Philippine Army reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

Tie breaking method shall be non-discretionary and non-discriminatory. The same shall be based on sheer luck or chance (Toss Coin) and in chronological order based on the submission of bids.

Section II. Instructions to Bidders

1. Scope of Bid

The Procuring Entity, Philippine Army wishes to receive Bids for the **Procurement of 13,928 each Poncho Tent, PHILARPAT under QM PABAC1 025-24.**

The Procurement Project (referred to herein as “Project”) is composed of **one lot**, the details of which are described in Section VII (Technical Specifications).

2. Funding Information

2.1. The GOP through the source of funding as indicated below for 2024 in the amount of **Fifteen Million Three Hundred Twenty Thousand Eight Hundred Pesos (Php15,320,800.00).**

2.2. The source of funding is: **National Expenditure Program CY 2024.**

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

4. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex “I” of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

5. Eligible Bidders

5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.

- 5.2. Foreign ownership exceeding those allowed under the rules may participate pursuant to:
- i. When a Treaty or International or Executive Agreement as provided in Section 4 of the RA No. 9184 and its 2016 revised IRR allow foreign bidders to participate;
 - ii. Citizens, corporations, or associations of a country, included in the list issued by the GPPB, the laws or regulations of which grant reciprocal rights or privileges to citizens, corporations, or associations of the Philippines;
 - iii. When the Goods sought to be procured are not available from local suppliers; or
 - iv. When there is a need to prevent situations that defeat competition or restrain trade.
- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least twenty-five percent (25%) of the ABC (Expendable Supplies)
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

6. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

7. Subcontracts

The Procuring Entity has prescribed that: **Subcontracting is not allowed.**

8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address and/or through videoconferencing/webcasting as indicated in paragraph 6 of the **IB**.

9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

10. Documents comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 10.2. The Bidder's SLCC as indicated in **ITB Clause 5.3** should have been completed within five (5) years prior to the deadline for the submission and receipt of bids.
- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.

11. Documents comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

12. Bid Prices

- 12.1. Prices indicated on the Price Schedule shall be entered separately in the following manner:
 - a. For Goods offered from within the Procuring Entity's country:
 - i. The price of the Goods quoted EXW (ex-works, ex-factory, ex-warehouse, ex-showroom, or off-the-shelf, as applicable);
 - ii. The cost of all customs duties and sales and other taxes already paid or payable;

- iii. The cost of transportation, insurance, and other costs incidental to delivery of the Goods to their final destination; and
 - iv. The price of other (incidental) services, if any, listed in e.
- b. For Goods offered from abroad:
- i. Unless otherwise stated in the **BDS**, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the **BDS**. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
 - ii. The price of other (incidental) services, if any, as listed in **Section VII (Technical Specifications)**.

13. Bid and Payment Currencies

- 13.1. For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.
- 13.2. Payment of the contract price shall be made in: **Philippine Pesos**.

14. Bid Security

- 14.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.
- 14.2. The Bid and bid security shall be valid within one hundred twenty (120) calendar days from the date of the opening of bids. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

15. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which

must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

16. Deadline for Submission of Bids

- 16.1. The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.

17. Opening and Preliminary Examination of Bids

- 17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

- 17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

18. Domestic Preference

- 18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.

19. Detailed Evaluation and Comparison of Bids

- 19.1. The Procuring BAC shall immediately conduct a detailed evaluation of all Bids rated "*passed*," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.

- 19.2. If the Project allows partial bids, bidders may submit a proposal on any of the lots or items, and evaluation will be undertaken on a per lot or item basis, as the case may be. In this case, the Bid Security as required by **ITB** Clause 15 shall be submitted for each lot or item separately.

- 19.3. The descriptions of the lots or items shall be indicated in **Section VII (Technical Specifications)**, although the ABCs of these lots or items are indicated in the **BDS** for purposes of the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184. The NFCC must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder.

- 19.4. The Project shall be awarded as follows:

One Project shall be awarded as one contract.

- 19.5. Except for bidders submitting a committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation, all Bids must include the NFCC computation pursuant to Section 23.4.1.4 of the 2016 revised IRR of RA No. 9184, which must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder. For bidders submitting the committed Line of Credit, it must be at least equal to ten percent (10%) of the ABCs for all the lots or items participated in by the prospective Bidder.

20. Post-Qualification

- 20.1. Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law and stated in the **BDS**.

21. Signing of the Contract

- 21.1. The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the **BDS**.



1. GENERAL

1.1 Scope - This specification covers one (1) type of Poncho Tent, Olive Drab (OD), Jungle Cover and reversible, for use of military personnel of the Armed Forces of the Philippines primarily as rain garment and combined raincoat-shelter tent, ground sheet and sleeping bag in the field.

1.2 Grade - The finished poncho shall conform to the quality and grade of product prescribed by this specification.

1.3 Size - The poncho shall be of one (1) size only, the dimensions of which are shown in the attached illustrations.

1.4 Color - The finished Poncho tent shall be Olive Drab or the Jungle Cover design to match the approved AFP standard for olive drab or camouflage design on one side.

2. MATERIALS

2.1 Basic Material - The base fabric shall be nylon, plain weave of continuous filaments and well-scoured.

2.2 The fabric shall be coated with polyurethane on one side suitably plasticized and pigmented to produce the prescribed basic colors. Reclaimed materials shall not be used.

2.3 Coated Fabric - The coating compound shall be applied to one side of the fabric. The olive drab face shall be coated thinly so that the weave of the base fabric is shown. The coated fabric shall be free from pinholes, perfectly waterproof and mildew-resistant. It shall be very pliable, light and does not stick to the skin. The coated fabric shall conform with the following requirements:

2.4 Eyelets.- The eyelets for the hood and valet drawcord tunnels of the poncho tent shall be made of brass, black chemical finished. The diameter and dimensions of the eyelets are as shown in the attached illustrations.

2.5 Gromets.- The grommets for the hem sides shall be Size No. 3, made of brass black chemical finish.

2.6 Snap Fasteners.- The snap fasteners shall consists of a socket and stud eyelet combination to enable assembly of a socket-stud combination in hem of the stud pot combination. The snap fastener shall be brass, ~~bronze~~ finished.

2.7 Draw Cords.- The drawcord shall be tubular and made of braided nylon. The drawcord shall have a minimum diameter of 4 mm. The braid shall be vat dyed and should be of the same bleaching or laundering when tested. The use of sulfur dyes is prohibited. The braid shall be made mildew-resistant. The end of the drawcords shall be either tipped or resin coated.

2.8 Reinforcement Materials.- The material to be used for reinforcing the snap fasteners and grommets shall be of the same material as specified in para 2.3.

2.8.1 Neck Seam Reinforcement shall be coated fabric of the same material as the fabric specified in para 2.3.

2.9 First Article – When specified, the contractor shall furnish sample unit(s) for first article inspection and approved against the bid sample.

3. CONSTRUCTION

The poncho tent shall be made by and with the use of all operations described below. The contractor is not required to follow the operation sequence as listed.

3.1 Cutting

3.1.1 The thicker coated side with the design shall be considered the reverse side of the fabric and shall be considered the underside.

3.1.2 The material shall be carefully laid in uniform widths and lengths and care must be taken in spreading the material so that the plies are not stretched and that one side of the lay is even.

3.1.3 All component parts of the poncho tent shall be cut of the same material in such a manner as to assure that they harmonize with each other in shade, except the waist cord tunnel, hood facing, neck reinforcement piece, peripheral hem and neck binding strip which may be cut from ends. The neck binding shall be a strip cut on the bias, not less than 1.9 cm nor more than 2.2 cm wide.

3.1.4 Cut hood drawcord to a length of 117cm +/- 1cm. Cut waist drawcord to a length of 170 cm +/- 1cm. Cut reinforcement pieces from specified material to 3.22 cm x 5 cm.

3.2 Join Side Pieces to Poncho Tent.- Seam the long sides to body of poncho tent with not less than 0.60 cm nor more than 0.79 cm triple wave sewed seam and sew on both sides of the fabric.

3.3 Grommets.- Eight (8) PVC grommets, size No. 3 as specified in para 2.4 shall be inserted in the four hems of the poncho tent, one in each corner and one in each hem equidistant from the corners.

3.4 Snap Fasteners.- The snap fasteners, brass shall be inserted in both long hems and shall be spaced 22.2cm apart, starting 15.2 cm from the center line of the center grommets when the poncho tent is folded in half either way, the snap fasteners shall correspond without gaping along the seams when fasteners are snapped together. This condition shall be true also when the reverse side is used. All snap fasteners and grommets on the sides of the poncho tent shall be sewed.

3.5 Neck Reinforcement.- The top of the poncho tent shall have outer and inner pieces of the coated matching fabric for supporting the hood. The reinforcement pieces shall be of the same material and matching shades to correspond with the two faces of the poncho tent. Position the neck reinforcement pieces at poncho tent with the upper edges even with the neck opening for both faces. Sew the lower edge of reinforcement pieces through poncho tent with the proper sewed seam.

3.6 Make Hood. - The hood facing shall consist of the left and right facing pieces of the basic fabric. Seam ends of left and right pieces at the back and at the front. The back seams shall be sewed with 12 to 14 stitches per 2.54 cm. Sealant shall be applied at the seam ends of left and right pieces at the back and at the front.

3.7 Seam Facing to Front of Hood

3.7.1 Seam facing to front hood to form tunnel for face drawcord. Do the same on the reverse side. Thread drawcord through grommets with drawcord crossing between grommets inside the facing.

3.7.2 Thread ends of drawcord through slide keeper and knot ends. Grommets should likewise be provided on the reverse side for proper threading of drawcord.

3.7.3 Position drawcord around periphery of hood.

3.7.4 Turn down the facing over drawcord, turning the edge and sew 4cm from the edge forming the tunnel. The back edge of hood facing may be hemmed prior to the seaming operation.

3.7.5 The joining seams at the top shall be positioned or adjacent to the hood joining seams. The joining seams at the bottom shall be centered between the face drawcord grommets at the front. A center tolerance of 1.27cm is allowed for both positions.

3.8 Join Hood to Neck of Poncho Tent.-

3.8.1 Seam hood to neck of poncho tent through neck reinforcement binding strip for both side of faces.

3.8.2 Turn binding strip over raw edge of seam allowance and sew thru hood 0.16cm from bound edge. A corresponding binding strip shall be sewed on the reverse side.

3.8.3 Binding strip maybe attached with folder adjoining of hood to neck of poncho tent through neck reinforcements. Sealant shall be applied to the stitchings.

3.9 Make Waist Drawcord Tunnel of Poncho Tent.- Position center of waist tunnel inside the front of poncho tent 38cm +/- 1cm from neck with ends equidistant from the center line. Turn in sides and ends of tunnel and sew through poncho tent 0.16cm to 0.32cm from edge.

3.10 Cleaning.- The finished poncho tent shall be thoroughly cleaned with all spots and stains removed. There shall be no appreciable defects such as stitching of coating and cracks on the surface of the finished poncho tent.

4. WORKMANSHIP

4.1 Design – The poncho tent shall conform to the attached illustration. The poncho tent shall have sides that are hemmed and shall be equipped with snap fasteners for closing as well as grommets for attaching tent pins. It shall have a hood with drawcord for the closing and drawcord for waist adjustment.

4.2 "AFP" Marking.- Each poncho tent shall have an "AFP" marking on the back bottom side applied by silk screening method using colorfast vinyl ink. The size, type and proper location of the lettering are so specified in the attached illustration.

4.3 Finish – The poncho tent shall be reversible, clean, well finished, thoroughly waterproof and free from any defects or blemish which may affect its appearance or serviceability. Poor quality of workmanship shall be sufficient ground for rejection of the finished article.

4.4 Contractor's Label – Each poncho tent shall have a contractor's label applied by silk screening method using colorfast vinyl ink. Position of the label is as shown in the attached illustration. The contractor's label shall consist of the following:

The letters "PONCHO TENT" shall be 0.48cm in height while the rest of the label data shall be 0.32 cm high. Non-compliance with this requirement shall be sufficient ground for rejection of the finished article.

5. QUALITY ASSURANCE PROVISIONS:

5.1 Responsibility for Inspection – Unless otherwise specified in the contract or purchase order, the contractor is responsible for the performance of all inspection requirements as specified herein. Except as otherwise specified in the contract or purchase order, the contractor may use his own or any other facilities suitable for the performance of the inspection requirements specified herein, unless disapproved by the Government. The Government reserves the right to perform any of the inspections set forth in this document where such inspections are deemed necessary to assure supplies and services conform to prescribed requirements

5.1.1 Responsibility for Compliance – All items must meet all requirements of Sections 2 and 3. The inspection set forth in this document shall become a part of the contractor's overall inspection system or quality program. The absence of any inspection requirements in the document shall not relieve the contractor of the responsibility of assuring that all product or supplies submitted to the Government for acceptance comply with all requirements of the contract. Sampling in quality conformance does not authorize submission of known defective material, either indicated or actual, nor does it commit the Government to acceptance of defective material.

5.2 First article inspection – The first article submitted in accordance with para 3.9 shall be inspected if it is in accordance with this specification.

5.3 Component and material inspection.- In accordance with para 4.1 above, components and materials shall be tested in accordance with all the requirements of this specification.

5.3.1 The bid samples of the poncho tent shall be submitted to the Research and Development Center, AFP to determine the extent of compliance with this specification as to the quality of materials used is concerned. The Office of The Quartermaster General, AFP shall determine the extent of compliance with the specification insofar as workmanship, style and finish are concerned.

6. PACKAGING AND PACKING:

6.1 Packaging – Ten (10) pieces of poncho tent shall be placed in a transparent (cellophane) bag. The open end of the bag shall be folded and closed with a transparent tape.

6.2 Packing – Five (5) bags or fifty (50) pieces of poncho tent shall be properly packed in a corrugated carton. The top cover when closed, shall be sealed with a binding tape and finally secured with nylon straps. The box shall be labelled as follows:



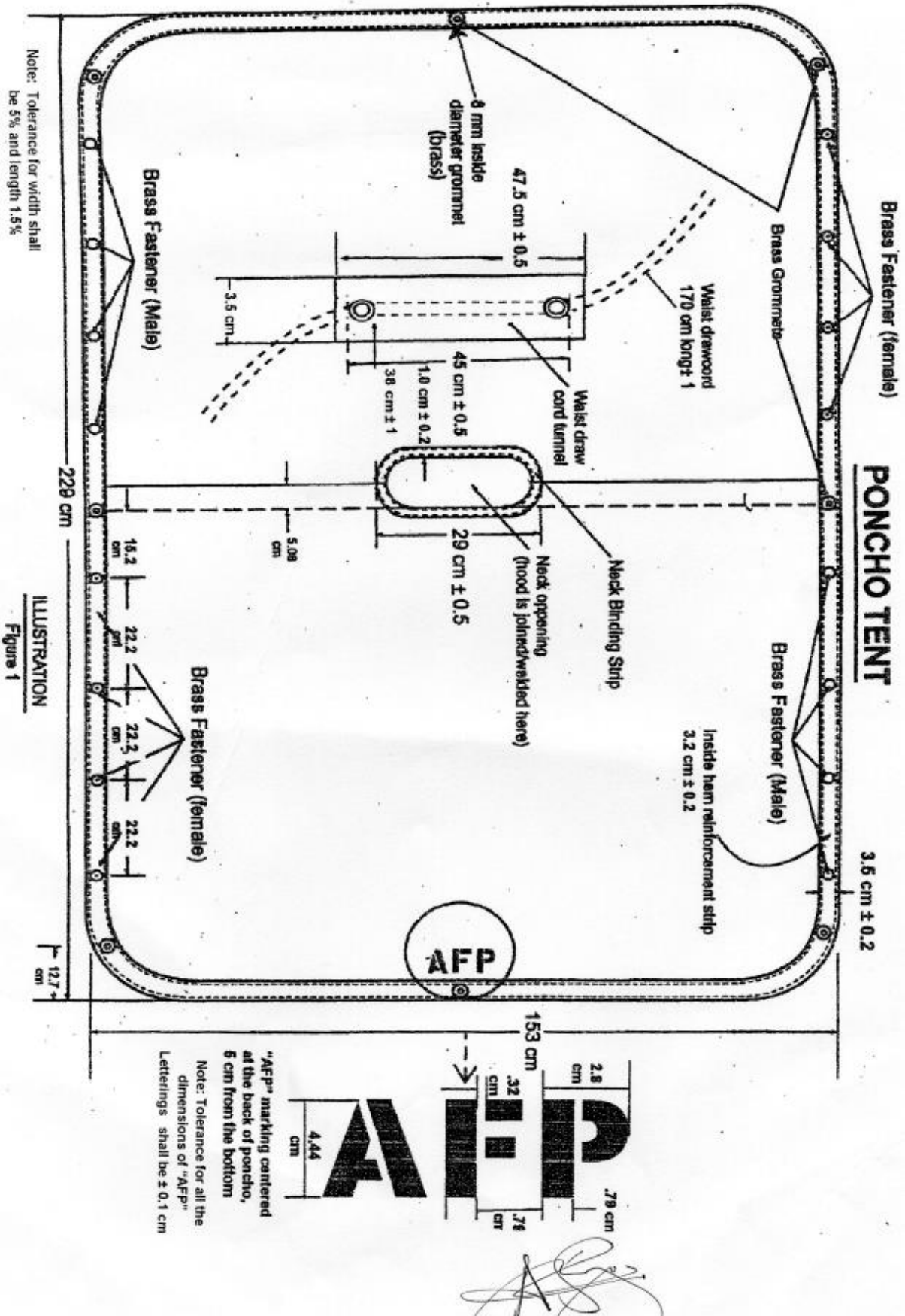
