
**NOTICE OF CONDUCT OF NEGOTIATED PROCUREMENT

The Philippine Army, through its Bids and Awards Committee 2, will conduct a negotiated procurement, after two consecutive failed biddings, pursuant to Section 53.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, for the **Procurement of One (1) Lot Cartridge, 120mm: HE (GMMS)** with the **Approved Budget for the Contract (ABC)** of **Two Hundred Ten Million Three Hundred Fifty-three Thousand Twenty-one Pesos (Php210,353,021.00)** only.
2. Interested/invited bidders may submit their Best and Final Offers for negotiation to the PABAC2 Secretariat at the Office of the PABAC2, Fort Andres Bonifacio, Taguig, Metro Manila, on or before **August 19, 2022, at 9:30 AM**. No Submissions shall be accepted after this hour. Offers should, in no case, exceed the ABC for the project.
3. The Best and Final Offer shall include the Statement of Compliance with the Technical Specifications in accordance with **Annex "A"**, the eligibility documents enumerated under **Annex "B"**, and the Price Quotation under **Annex "C"**.
4. To facilitate the submission of the best and final offers, bidders are requested to submit their eligibility documents in the order indicated in the herein Annexes. Bidders shall provide **one (1) original copy of the documents** to be submitted in a sealed envelope duly signed by the Bidder or its authorized representative.
5. The successful offer shall be selected on the basis of the Best and Final Offer [*Compliance with the Technical Specifications, Eligibility Documents, and Price Quotation*].
6. The Procuring Entity reserves the right to accept or reject any offer, to annul the negotiation process, and to reject all offers at any time prior to contract award, in accordance with law, without incurring any liability to the affected participants.
