**REQUEST FOR EXPRESSION OF INTEREST  
FOR CONSULTING SERVICES FOR THE PREPARATION OF ARCHITECTURAL AND ENGINEERING  
DESIGNS**

1. The **Philippine Army**, through the General Appropriations Act CY 2023 intends to apply the sum of **FIVE MILLION THREE HUNDRED FOUR THOUSAND PESOS (PhP5,304,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Consulting Services for the Preparation of Architectural and Engineering Designs under Consulting SVCS PABAC1 001-23**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.

The **Philippine Army** now calls for the submission of eligibility documents for **Consulting Services for the Preparation of Detailed Architectural and Engineering Designs under Consulting SVCS PABAC1 001-23**. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **10 August 2023 at 9:00 A.M. at PABAC1 Secretariat NCO Clubhouse, Fort Andres Bonifacio, Taguig City**. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion. The consultant/s shall drop one (1) original and three (3) photocopies of their duly accomplished eligibility requirements in sealed envelopes in the bid box located at the above-mentioned address.

- Prospective Bidders may obtain further information from PABAC1 Secretariat and also downloaded the Bidding Documents as posted on the Website of the Philippine Army and the PHILGEPS at the address given below during office hours from 8:00 am to 4:00 pm on weekdays only **(except holidays)**.
- A complete set of Bidding Documents may be acquired by interested Bidders on **02 August 2023** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (PhP10,000.00)*** at the Collecting Officer, Finance Center, Philippine Army, Fort Andres Bonifacio, Metro Manila. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile, or through electronic means.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), [www.philgeps.gov.ph](http://www.philgeps.gov.ph) and the website of the Philippine Army, [army.mil.ph](http://army.mil.ph), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

<b>Criteria</b>	<b>Points</b>
<b>Applicable Experience of the Consultant</b>	40
<b>Personnel Complement</b>	50
<b>Current Workload</b>	10
<b>TOTAL POINTS</b>	<b>100%</b>

- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- The Procuring Entity shall evaluate bids using the Quality-Cost Based Evaluation/Selection (QCBE/QCBS), procedure. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
- The contract shall be completed within **One Hundred Twenty (120) Calendar Days**.
- The **PA Bids and Awards Committee 1 (PABAC1)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
