INVITATION TO BID

**Procurement of Medical Equipment
under MED PABAC1 005-24 (Re-Bid)**

Lot 2

**Two (2) units HBA1C, Fully Automated
Eleven (11) units Electrocardiogram, Fully Automated
Eleven (11) units Chemistry Analyzer, Fully Automated
Two (2) units Hematology Analyzer, Fully Automated**

1. The Philippine Army, through **Advice of Allotment Nr 2024-02-08 dated 07 June 2024 (PAGC Revolving Fund)** intends to apply the sum of **Lot 2 – PhP25,123,545.10** being the ABC to payments under the contract for **MED PABAC1 005-2024**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Army** now invites bids for the above Procurement Project. Delivery of the Goods is required within **Ninety (90) calendar days** from the receipt of Notice to Proceed (NTP), which date shall not be later than seven (7) days from the issuance of NTP. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Prospective Bidders may obtain further information from the **Philippine Army** and inspect the Bidding Documents at the address given below during office hours (8:00AM to 5:00PM) on weekdays only.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **September 07, 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
6. The **Philippine Army** through PABAC1 will hold a Pre-Bid Conference on **September 16, 2024** at **Office of the PA Bids and Awards Committee 1 (PABAC1) Conference Room, PABAC Building, Fort Bonifacio, Taguig City** and/or through Video Teleconferencing/Webcasting via **ZOOM**, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the **Office of the PA Bids and Awards Committee I (PABAC1) Secretariat, PABAC Building, Fort Bonifacio, Taguig City**, on or before **September 30, 2024**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on the date and address specified below and/or through Video Teleconferencing or Webcasting. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Philippine Army reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

The tie-breaking method shall be non-discretionary and non-discriminatory. It shall be based on sheer luck or chance (Toss Coin) and in chronological order based on the submission of bids.
