**INVITATION TO BID FOR Procurement of
Replacement Parts for Mounted Armaments
(12.7mm RCWS 1st Generation)**

1. The *Philippine Army*, through the *ASA Number 2300-2024-0001 FY 2023 (Continuing)* intends to apply the sum of *Fourteen Million Five Hundred Eight Thousand Nine Hundred Sixty-One Pesos (PhP14,508,961.00)* only, being the Approved Budget for the Contract to payments under the contract for *Procurement of Replacement Parts for Mounted Armaments (12.7mm RCWS 1st Generation) with Project Identification Number ArmorDivSBAC(ARMOR)-PB-025-23*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Philippine Army* now invites bids for the above Procurement Project. Delivery of the Goods is required by **Three Hundred (300) Calendar Days** reckoned from the date of receipt of Noticed to Proceed (NTP). Bidders should have completed, within the period of five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Prospective Bidders may obtain further information from *Philippine Army* and inspect the Bidding Documents at the address given below during *office hours*.

A complete set of Bidding Documents may be acquired by interested bidders on **January 04, 2024** from the **Armor Division, Philippine Army, Office of the Special Bids and Awards Committee, Sta Lucia, Capas, Tarlac** and can be downloaded through PHILGEPS upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (Php**

25,000.00) only. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person**.

6. The **Philippine Army through Armor Division Special Bids and Awards Committee** will hold a Pre-Bid Conference on **January 11, 2024, Thursday at 9:00 a.m.** at Pambato Officers' Clubhouse, Armor (Pambato) Division, Philippine Army, Camp O'Donnell, Sta. Lucia, Capas, Tarlac and/or through video conferencing or webcasting via ZOOM, which shall be opened to prospective bidders.

7. Bids must be duly received by the SBAC Secretariat through manual submission at the office address indicated below on or before **January 25, 2024, Thursday at 8:30 a.m.** Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

9. Bid opening shall be on **January 25, 2024, Thursday at 9:00 a.m.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. The **Philippine Army** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
