**INVITATION TO BID FOR PROCUREMENT of Vision
Blocks and View Blocks for Armored Vehicles**

1. The **Philippine Army**, through the **National Expenditure Program FY 2024** intends to apply the sum of **Seventeen Million Three Hundred Sixty-Six Thousand Four Hundred Sixty Two 50/100 Pesos (PhP17,366,462.50)** only, being the Approved Budget for the Contract to payments under the contract for **Procurement of Vision Blocks and View Blocks for Armored Vehicles with Project Identification Number ArmorDivSBAC(ARMOR)-PB-16-2024**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Philippine Army** now invites bids for the above Procurement Project. Delivery of the Goods is required by **Ninety (90) Calendar Days** reckoned from the date of receipt of Noticed to Proceed (NTP). Bidders should have completed, within the period of five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

A complete set of Bidding Documents may be acquired by interested bidders on **November 23, 2023** from the **Armor Division, Philippine Army, Office of the Special Bids and Awards Committee, Sta Lucia, Capas, Tarlac** and can be downloaded through PHILGEPS upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty Five Thousand Pesos (PhP**

25,000.00) only. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person**.

6. The **Philippine Army through Armor Division Special Bids and Awards Committee** will hold a Pre-Bid Conference on **November 29, 2023 (Wednesday) at 10:30 a.m.** at Armor Pambato Division Clubhouse, Armor (Pambato) Division, Philippine Army, Camp O'Donnell, Sta. Lucia, Capas, Tarlac which shall be opened to prospective bidders.

7. Bids must be duly received by the SBAC Secretariat through manual submission at the office address indicated below on or before **December 13, 2023 (Wednesday) at 8:30 a.m.** Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

9. Bid opening shall be on **December 13, 2023 (Wednesday) at 09:00 a.m.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. The **Philippine Army** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
